

**AN ACT TO AUTHORIZE THE SALE OF A THREE
HUNDRED NINETY-FOUR (394) SQUARE METER
IRREGULAR REMNANT PORTION OF THE OLD *PITI-
AGAÑA* ROAD FRONTING LOT 85-2-R1 IN THE
MUNICIPALITY OF *PITI*.**

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that the realignment and transformation of the old *Piti-Agaña* Road in the 1950s into the present-day Route 1 Marine Corps Drive from the front main gate of Andersen Air Force Base Guam to the front main gate of Naval Station Guam resulted in the severance and creation of certain irregular and remnant parcels along the way.

Section 2. Authorization to Sell Government of Guam Land. *I Mina'Trentai Kuåttro Na Liheslaturan Guåhan* hereby authorizes *I Maga'låhen Guåhan* to sell approximately three hundred ninety-four (394) square meters of that portion of the old *Piti-Agaña* Road fronting Lot 85-2-R1 in the municipality of *Piti*, as shown in Map No. 039FY85 recorded under Document No. 352565 at the Department of Land Management, to be purchased by Micronesia Divers Association, Inc., a Guam corporation.

1 The Department of Land Management and Micronesian Divers Association,
2 Inc. *shall* complete the sale.

3 Exhibit A depicts the boundaries of the three hundred ninety-four (394)-
4 square meter left-over, irregular remnant portion of the old *Piti-Agaña* Road to be
5 purchased by Micronesian Divers Association, Inc.

6 **Section 3. Appraisals.** 2 GCA § 2107(b) relative to appraisals of
7 government land *shall* apply to this Act.

8 **Section 4. Proceeds of Sale.** Funds generated from the sale *shall* be
9 deposited in the Chamorro Land Trust Survey and Infrastructure Fund, identified as
10 Chamorro Land Trust Revenue Account Number 3669-57001, CLT-Sale of
11 Government Land.

12 **Section 5. Severability.** If any provision of this Act or its application to
13 any person or circumstance is found to be invalid or contrary to law, that invalidity
14 *shall not* affect other provisions or applications of this Act, that can be given effect
15 without the invalid provisions or applications, and to this end the provisions of this
16 Act are severable.
