AN ACT TO APPROPRIATE THE SUM OF FIVE MILLION DOLLARS FROM THE GENERAL FUND TO THE GUAM MEMORIAL HOSPITAL AUTHORITY FOR ITS OPERATIONS IN FISCAL YEAR 2018, INCLUSIVE OF CORRECTING THE DEFICIENCIES AS IDENTIFIED IN THE CENTERS FOR MEDICAID AND MEDICARE SERVICES.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the Tax Amnesty Program for Fiscal Year 2018 is expected to generate in excess
4 of \$30,000,000 in additional General Fund revenues. It is the intent of *I Liheslatura*
5 to authorize and appropriate such sum as identified in this Act to the Guam Memorial
6 Hospital Authority to subsidize its operations for Fiscal Year 2018 inclusive of
7 correcting the deficiencies as identified in the Centers for Medicaid and Medicare
8 Services.

9 **Section 2. Appropriation to GMHA.** The sum of Five Million Dollars
10 (\$5,000,000) is appropriated from the General Fund to the Guam Memorial Hospital
11 Authority for its operations in Fiscal Year 2018 inclusive of correcting the
12 deficiencies as identified in the Centers for Medicaid and Medicare Services.

13 **Section 3. Effective Date.** This Act *shall* become effective upon enactment.

14 **Section 4. Severability.** *If* any provision of this Act or its application to any
15 person or circumstance is held invalid, the invalidity *shall not* affect other provisions

- 1 or applications of this Act which can be given effect without the invalid provision
- 2 or application and to this end the provisions of this Act is severable.
