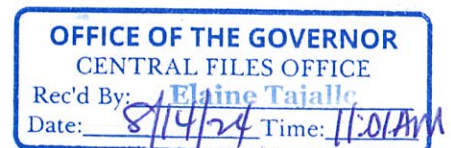
1. The Legislature did consent to the Executive Reappointment of Earl J. Garrido to serve as a Member of the CHamoru Land Trust Commission.


