8. The Legislature did consent to the Executive Reappointment of Margaret E.R. Tyquiengco to serve as a Member of the Guam Ethics Commission.

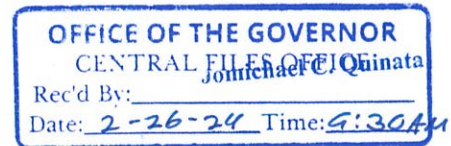
